Notes on Serving of Suspensions

Players of Scottish Premier League Clubs or Scottish Football League Clubs

Suspensions incurred by players shall be served in the competition in which they are incurred and shall be measured by the relevant team of the club (i.e. the team in which the player normally plays) playing the requisite number of matches.

The following qualification applies:-

A player who is sent off for serious foul play, violent conduct or spitting at an opponent or any other person, is suspended automatically until such time as his club's team(s) has completed a match in a competition for which he would otherwise be eligible for selection. (Please refer to Appendix 3 of the Disciplinary Procedures – Guidance Notes on Serving of Suspensions).

During any period of suspension a player shall be eligible to play in:

1. International Matches.
2. Matches in the U.E.F.A. Club Competitions.
3. Matches in other Scottish Premier/Scottish Football League Competitions in which his club is participating, when sent off for any offence not referred to in the above qualification, and where eligible to be selected.
4. Matches in the Specified Cup Competitions (unless the above qualification applies).
5. Matches not included in the Association's Register of Competitions.
6. Matches played under the auspices of a District or County Football Association.

Players of clubs not in Membership of the Scottish Premier League or the Scottish Football League

Suspensions incurred by players shall be served and measured by the club's recognised first team playing the requisite number of matches in a competition included in the Association's Register of Competitions, with the exception of matches in the Specified Cup Competitions when the following qualification applies:-

A player who is sent off for serious foul play, violent conduct or spitting at an opponent or any other person, is suspended automatically until such time as his club's recognised first team has played its next match, included in the Association's Register of Competitions irrespective of the competition.

During any period of suspension a player shall be eligible to play in: -

1. International Matches.
2. Matches in the Specified Cup Competitions (unless the above qualification applies).
3. Matches not included in the Association's Register of Competitions.

An automatic one match suspension applies immediately and is not dependent upon a club receiving confirmation from the Association of the player's sending off.
