Misconduct report forms and other relevant correspondence arising from matches, should be sent to the SFA Disciplinary Department, Hampden Park, Glasgow, G42 9AY.

The dates of birth of players being reported for misconduct to the Scottish Football Association should be denoted on the misconduct report form by referees, where the information is provided on teamlines.

Drawn Tie

When a game is drawn after 90 minutes of play, the winner shall be determined by the taking of kicks from the penalty mark in accordance with the rules laid down by the International Football Association Board.

Match Fees and Expenses

Fees and expenses of the referee and assistant referees are settled by the home club on the day of the match.

The match fees are: Referee - £47.00/Assistant Referee - £24.00

Expenses are paid at a rate of 30 pence per mile. Where officials share transport the passengers will be paid an allowance of £3.00 irrespective of the distance travelled.

Pitch Inspections/Postponements

If the ground is unplayable the Home Club must inform their opponents, the referee, the assistant referees and the League Secretary without delay as soon as the decision is made.
