- Difficulty Levels

 1. A simple decision that all officials should get correct.

 2. A fairly simple decision for a select group official, though with more factors to consider.
- 3. A more complex decision with a greater degree of subjectivity and/or more factors to consider, that a select group official should nonetheless call correctly. 4. A difficult decision for officials with a high degree of subjectivity or challenging considerations to identify. One that needs deliberation. A 50/50 call.
- 5. A particularly tough decision that all referees would struggle with. The type of judgement where technology is needed to support officials.
