Scottish Government

Part 5 of the Community Empowerment Act introduces a right for community bodies to make requests to all local authorities, Scottish Ministers and a wide-ranging list of public bodies, for any land or buildings they feel they could make better use of. They can request ownership, lease or other rights, as they wish. The Act requires those public authorities to transparently assess requests against a specified list of criteria, and to agree the request unless there are reasonable grounds for refusal. The Act sets out the key rights and duties and provides a framework for the asset transfer process. Regulations and Orders set out more detailed arrangements for implementing the scheme.

It centres of five strategic priorities: embedding a consistent child wellbeing and protection system throughout the game; promoting children's rights in all we do; support and develop learning and knowledge of child protection and wellbeing; improve standards at all level; and strengthen leadership, governance and accountability.

GIRFEC Getting it right for every child - GIRFEC is the national approach in Scotland to improving outcomes and supporting the wellbeing of our children and young people by offering the right help at the right time from the right people. It supports them and their parent(s) to work in partnership with the services that can help them.

WELLBEING WHEEL Wellbeing is broader than child protection and how we tend to think about welfare. To help make sure everyone – children, young people, parents, and the services that support them – has a common understanding of what wellbeing means, we describe it in terms of eight indicators. The eight wellbeing indicators are commonly referred to by their initial letters - SHANARRI.

MY WORLD TRIANGLE Using the My World Triangle (and where appropriate, specialist assessments) to gather further information about the needs of the child or young person. When working with children or young people, the My World Triangle is used at every stage to think about the whole world of the child or young person.

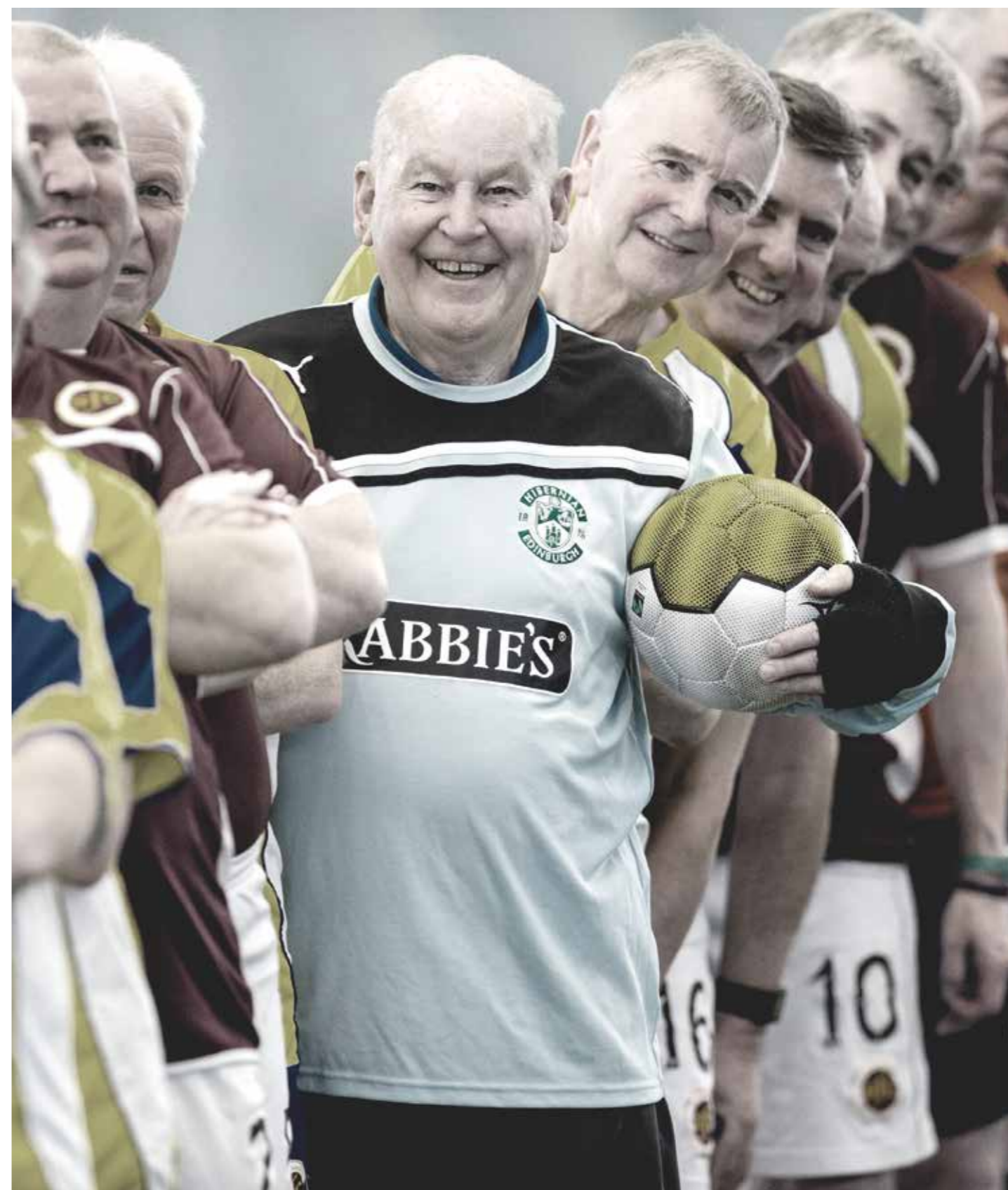
